Estimated Need: \$1,800,000,000

This request would provide \$1.8 billion to the Office of the Secretary account within the U.S. Department of Agriculture to fund the Emergency Relief Program (ERP). The ERP provides "top up" payments, which are in addition to what producers receive from crop insurance, as a consequence of hurricanes and drought in calendar year 2022.

Account: Emergency Forest Restoration Program

Estimated Need: \$97,000,000

This request would provide a total of \$97 million for the Emergency Forest Restoration Program of the Farm Service Agency within the U.S. Department of Agriculture, which helps owners of private forestland with debris removal, replanting forest stands, restoration of forestland roads or erosion control, and fencing in response to natural disasters. Of the total amount requested, \$27 million is for hurricane response and recovery activities and \$70 million is for non-hurricane disaster recovery needs. The Administration is committed to enduring these funds are targeted, as appropriate, to Tribes and disadvantaged communities.

Estimated Need: \$680,000,000

This request would provide a total of \$680 million for the Emergency Watershed Protection Program account of the Natural Resources Conservation Service within the U.S. Department of Agriculture, which helps local communities relieve imminent threats to life and property caused by floods, fires, windstorms, and other natural disasters that impair a watershed. Of the total amount requested, \$250 is for hurricane response and recovery activities and \$430 million is for other disaster recovery needs. The Administration is committed to ensuring these funds are targeted, as appropriate, to Tribes and disadvantaged communities.

Estimated Need: \$60,000,000

This request would provide \$60 million to the Rural Housing Assistance Grants account of the U.S. Department of Agriculture (USDA) for housing repair grants to repair hurricane damaged homes. Language is needed to: authorize grants to populations of 50,000 or less; remove the age limitation; and raise the income limit to 80 percent of area median income. In addition, language is needed to authorize USDA to set aside five percent of funding for administrative expenses.

Language is needed to authorize grants to populations of 50,000 or less. The Administration is committed to ensuring these funds are targeted, as appropriate, to Tribes and disadvantaged communities.

Estimated Need: \$265,000,000

This request would provide \$265 million to the Rural Water and Waste Disposal Program Account of the U.S. Department of Agriculture (USDA) for water and wastewater grants. This funding would be used to repair clean drinking water facilities and wastewater treatment plants in rural areas. Of the amounts provided, \$165 million is for infrastructure repairs needed for water treatment facilities sustaining damage due to fiscal year (FY) 2023 hurricanes and \$100 million is to mitigate damage as a result of FYs 2022 and 2023 flooding in Kentucky. Language is needed to authorize grants to facilities located in communities of 50,000 or less. In addition, language is needed to authorize USDA to set aside three percent of funding for administrative expenses and \$10 million for technical assistance grants. The Administration is committed to ensuring these funds are targeted, as appropriate, to Tribes and disadvantaged communities.

This request would provide \$929 million to Forest Service Operations account of the Forest Service within the Department of Agriculture for critical information technology and infrastructure investments to modernize suppression operations. Language is needed to limit this funding to the Wildland Fire Management mission area.

In addition, language is needed to authorize the transfer of \$2 million to the Office of Inspector General account and up to three percent of the total funding to the Salaries and Expenses account for administration and oversight, consistent with prior EDA disaster appropriations.

This request would provide \$7 million to the Operation and Maintenance, Army Reserve, account within the Department of Defense (DOD). This funding would support clean-up efforts and to repair damaged DOD facilities caused by Hurricanes Ian and Fiona.

This request would provide \$17 million to the Operation and Maintenance, Army, account within the Department of Defense (DOD). This funding would support clean-up efforts and to repair damaged DOD facilities caused by Hurricanes Ian and Fiona.

This request would provide \$41 million to the Military Construction, Navy, account within the Department of Defense (DOD). This funding would support clean-up efforts and to repair damaged DOD facilities caused by Hurricanes Ian and Fiona.

Estimated Need: \$3,035,000,000

This request would provide \$3.0 billion for the Grid Deployment Office account of the Department of Energy (DOE). Of the total amount requested, \$3 billion is for grants to low-income households in Puerto Rico to purchase and install solar and battery storage systems and energy distribution technology. These systems can increase resilience for households during blackouts and outages resulting from natural disasters.

Of the total amount requested, \$35 million is for: technical assistance to other agencies, local entities, and communities throughout Puerto Rico to assist with energy recovery and grid modernization activities; and salaries and travel expenses for dedicated DOE staff for Puerto Rico. These activities include convening stakeholders to prioritize near-term investments and develop mitigation strategies against future storms and working directly with communities to design specific energy solutions.

This request would provide \$150 million to the Department of Energy's Cybersecurity, Energy Security, and Emergency Response account to support a suite of activities to advance resiliency of the Nation's electricity infrastructure. Funding would be available to States, Territories, and Tribes to conduct rapid risk assessments to address energy resource constraints facing energy systems. In addition, funding would be available to implement mitigation measures based on those assessments to support utilities in accelerating response time to outages to protect public health and safety.

Account: Construction, Rehabilitation, Operation and Maintenance,

Estimated Need: \$120,000,000

This request would provide \$120 million to the Construction, Rehabilitation, Operation and Maintenance account of the Western Area Power Administration for purchase, power, and wheeling funds to offset lost generation from the Glen Canyon Project dam bypass in the summer of 2023.

Estimated Need: \$500,000,000

This request would provide \$500 million to the Department of Health and Human Services to increase funding for household energy assistance through the Low Income Home Energy Assistance Program (LIHEAP). In addition to subsidizing home heating costs this winter and covering unpaid utility bills, this funding would help families make cost-effective home energy repairs to lower their heating and cooling bills. This funding could be applied to assist households with higher energy expenses due to disasters and extreme weather events occurring nationally. Half of the funds would be distributed under the old LIHEAP formula and the other half would be distributed under the new formula.

This request would provide \$575 million to the Department of Health and Human Services (HHS) for Social Services Block Grant funding (SSBG) to address social service needs arising from Hurricanes Ian and Fiona. Grantees would have flexibility to use funding for a range of activities including child care, emergency social services, food assistance, case management, and other supportive services for families and individuals affected by the hurricanes, as well as for the repair or improvement of social service facilities.

In addition, language is needed to authorize HHS to set aside up to two percent (\$12 million) of funding to cover Federal administrative expenses (e.g., program oversight and technical assistance).

Since SSBG funds are allocated through a statutory formula, language would also be needed to target the funds to States and Territories with the greatest social services needs resulting from the hurricanes.

This request would provide \$345 million to the Department of Health and Human Services (HHS) for the Head Start program to support the recovery and reopening of Head Start programs in areas affected by Hurricanes Ian and Fiona. HHS estimates that there are 1,500 centers in affected areas, and funds would be used to repair damaged facilities, hire staff, and provide transportation for some of the students to the centers. Funding would also support HHS in providing training and technical assistance to help centers resolve immediate and long-term problems resulting from these disasters.

Estimated Need: \$240,257,000

This request would provide \$240 million to the Public Health and Social Services Emergency Fund (PHSSEF) account in the Department of Health and Human Services (HHS) for response, recovery, and mitigation efforts related to Hurricanes Ian and Fiona. This funding would be allocated as follows:

Of the total, \$357,000 is for the Food and Drug Administration (FDA) to repair and replace facilities and equipment damaged by Hurricane Fiona at the San Juan, PR location, including to gates, roofs, and ramps, replacement of a portable air compressor, ceiling tiles, storm shutters, and a guard booth. In addition, FDA would add a larger diesel fuel storage tank to increase capacity from 3,000 gallons to 15,000 gallons to enable the facility to continuously operate for up to 35 days versus the current eight-day operating cycle before additional fuel is needed.

Of the total, \$65 million is for the Health Resources and Services Administration to provide funding to Health Centers in affected areas to recover and prepare for future disasters.

Of the total, \$86 million is for the Centers for Disease Control and Prevention to provide critical public health response activities, including support to affected States and Territories working to respond and recover from the impacts of Hurricanes Ian and Fiona. Response activities would help address environmental health impacts and vector-borne, food-borne, water-borne, and other infectious diseases that arise as a result of the hurricanes.

Of the total, \$27.5 million is for the National Institutes of Health to support recovery and cleanup operations through the Superfund Worker Training Program, and to provide administrative supplements and awards for extramural grantees to restore impacted research and infrastructure.

Of the total, \$22 million is for the Substance Abuse and Mental Health Services Administration to address workforce shortages, rebuild critical behavioral health infrastructure, and meet anticipated mental health and substance use treatment needs for people who would otherwise not have access through steady-state or public behavioral health resources.

Of the total, \$15 million is for the Administration for Community Living for aging and disabilities programs for the provision of direct services, additional food, supplies, and extra

home delivered meals. Funding is also needed to repair and replace senior centers and nutrition sites impacted by the hurricanes.

Of the total, \$24.4 million is for the Administration for Strategic Preparedness and Response for the National Disaster Medical System to replace medical caches used during hurricane response efforts and to expand the number of field hospitals to ensure response capacity is sufficient to address large scale and multi-disaster events.

In addition, language is needed: to authorize transfers from the PHSSEF account to other appropriations of HHS for the purposes specified above; for direct hire authority for 270 days to fill positions that have a direct role in public health preparedness and response activities related to Hurricanes Ian and Fiona; and for premium pay, overtime, and danger pay during a declared public health emergency.

This request would provide \$124 million to the Procurement, Construction, and Improvements account of the U.S. Coast Guard within the Department of Homeland Security for repairs to facilities damaged by Hurricanes Ian and Fiona.

Account: Disaster Relief Fund

Estimated Need: \$11,000,000,000

This request would provide \$11 billion to the Disaster Relief Fund account of the Federal Emergency Management Agency within the Department of Homeland Security to address ongoing response and recovery costs for disasters, including Hurricanes Ian and Fiona. Funding would be used for debris removal, emergency protective measures, temporary housing, and repairing and rebuilding public infrastructure. Funding in this request will support the appropriate federal cost share for disasters of this magnitude.

This request would provide \$2.9 billion to the Hermit's Peak/Calf Canyon Fire Assistance account of the Federal Emergency Management Agency within the Department of Homeland Security to address outstanding claims for the Hermit's Peak fire in New Mexico.

This request would provide \$4 billion to the Federal Emergency Management Agency within the Department of Homeland Security for the National Flood Insurance Program to pay claims associated with Hurricane Ian and other disasters as necessary.

This request would provide \$3.5 billion to the Department of Housing and Urban Development for the Community Development Fund for unmet disaster recovery and mitigation needs in the most impacted and distressed areas from major disasters in 2022 and 2023, including Hurricanes Ian and Fiona, and consistent with emergency funding already provided for 2022 disasters. In addition, the Administration looks forward to working with the Congress to enact a permanent authorization of the Community Development Block Grant - Disaster Recovery program.

Account: Surveys, Investigations, and Research

Estimated Need: \$41,040,000

This request would provide \$41 million to the Department of the Interior, U.S. Geological Survey for various recovery efforts related to Hurricanes Ian and Fiona (\$20 million) and Typhoon Merbok in Alaska (\$21 million). The funding would be used to repair and harden monitoring systems that were damaged in the storms, support mapping of impacted areas, and update and improve community risk assessments that would help mitigate the risks faced by tribal and other communities from future storms.

Estimated Need: \$212,267,000

This request would provide \$212 million to the Department of the Interior, U.S. Fish and Wildlife Service to repair damage from Hurricanes Ian (\$119 million) and Fiona (\$72 million) and recent storms in Alaska (\$1 million), and to address the impacts of other disasters such as flooding and landslides in Midway National Wildlife Refuge (\$20 million).

Estimated Need: \$1,266,168,000

This request would provide \$1.3 billion to the Department of the Interior, National Park Service for disaster recovery efforts at a variety of National Parks. The funding would be used to: repair damages from Hurricane Ian (\$195 million); rebuild Yellowstone National Park after flooding in June 2022 (\$916 million); and recover from the impacts of landslides at Denali National Park and Reserve (\$115 million), flooding in Death Valley National Park (\$25 million), fires in Sequoia National Park (\$10 million), and other disasters affecting park units including Typoon Merbok in Alaska (\$5 million).

Estimated Need: \$47,000,000

This request would provide \$47 million to the Department of the Interior, Bureau of Indian Affairs to aid and repair western coastal communities in Alaska that experienced severe damage from Typhoon Merbok. The funding would support the purchase and shipping of materials, supplies, and other items for community repair efforts that the Federal Emergency Management Agency has confirmed will not be covered by existing disaster response funding, as well as recovery for subsistence food losses resulting from the typhoon. The Administration is committed to ensuring these funds are targeted, as appropriate, to Tribes and disadvantaged communities.

Account: Education Construction

Estimated Need: \$90,465,000

This request would provide \$90 million to the Department of the Interior Bureau of Indian Education to address damage resulting from severe flooding, most recently in June 2022, at the To'Hajiilee Community School in New Mexico. The funding would be used to support relocating the campus and constructing a new school at one of two identified possible locations outside of the floodplain since flood mitigation activities on the current campus are inadequate to protect the school from future flooding events. The Administration is committed to ensuring these funds are targeted, as appropriate, to Tribes and disadvantaged communities.

Estimated Need: \$346,000,000

This request would provide \$346 million to the Department of the Interior (DOI) Wildland Fire Management program for information technology (IT) and infrastructure investments to modernize suppression operations. Of the total funding requested, \$232 million would be used to improve wildland fire technological capabilities, including IT risk management, satellite imagery and remote sensing capabilities, and DOI's unmanned aerial systems. The remaining \$114 million would be used to support wildland fire facilities improvements by helping cover leasing costs.

The Administration believes it would be appropriate to provide a 100 percent cost share for costs associated with Hurricanes Ian and Fiona.

Estimated Need: \$1,667,210,000

This request would provide \$1.7 billion to the Environmental Protection Agency for Clean Water and Drinking Water State Revolving Loan Funds (SRFs) and water infrastructure grants. Of the total request, \$1.1 billion would be used to provide capitalization grants for water infrastructure damaged in Hurricanes Ian and Fiona, focusing on resilience projects that would mitigate future extreme weather damage. In addition, this request would waive the standard SRF State match requirements. The remaining \$600 million would be used to support water systems in counties that are currently subject to an emergency declaration not caused by a natural disaster. Funding would be used for management, operations, and maintenance support for the water systems, capital infrastructure needs, and debt relief of existing infrastructure loans. The Administration is committed to ensuring these funds are targeted, as appropriate, to Tribes and disadvantaged communities.

Account: Leaking Underground Storage Tank Trust Fund Program

Estimated Need: \$3,000,000

This request would provide \$3 million to the Environmental Protection Agency Leaking Underground Storage Tank Trust Fund Program for assessment and cleanup of underground storage tank sites to address any contamination resulting from, or exacerbated by, Hurricanes Ian and Fiona. The Administration is committed to ensuring these funds are targeted, as appropriate, to Tribes and disadvantaged communities.

This request would provide \$94 million to the National Aeronautics and Space Administration in the Construction and Environmental Compliance and Restoration account to repair facilities and restore shorelines at the Kennedy Space Center in Florida and the Wallops Flight Facility in Virginia from damage due to the effects of Hurricane Ian.

The request would provide \$760 million, of which up to \$506 million would be for administrative expenses, to the Small Business Administration for the Disaster Loan Program. This would provide for disaster loan subsidy and administrative costs to support the provision of low-cost loans to homeowners and businesses to repair or replace disaster damaged real and personal property.

## **Summary of Funding Request to Meet Critical Needs**

## Disasters

We need to help our communities recover and rebuild from extreme weather events and natural disasters. That's why we are requesting \$37.3 billion to fund critical disaster response and rebuilding efforts in Florida, Puerto Rico, and other communities across America that have faced severe flooding, wildfires, drought, and extreme heat over the past year. As the President often says, we must be there for these communities every step of the way—for as long as it takes.
