
I ask the Congress to consider the enclosed Fiscal Year (FY) 2024 Budget amendments for the Departments of Agriculture, Defense, Education, Homeland Security, Housing and Urban Development, and Transportation as well as the Environmental Protection Agency and for International Assistance Programs. These amendments would not change the base discretionary budget authority requested in my FY 2024 Budget.

Also included is an amendment providing increased amounts for the National Science Foundation (NSF) STEM Education account. This increase is fully offset from amounts provided from within NSF and the Department of Agriculture. Also included for consideration are amendments shifting amounts provided from within the Department of Defense for higher priority programs.

This transmittal also contains FY 2024 Budget amendments for the Legislative Branch. As a matter of comity and tradition, these appropriations requests for the Legislative Branch are transmitted without change. These amendments would decrease by \$17 million the overall discretionary budget authority in my FY 2024 Budget.

The details of this proposal are set forth in the enclosed letter from the Director of the Office of Management and Budget.

Dear Mr. President:

Submitted for your consideration are amendments to your fiscal year (FY) 2024 Budget for the Departments of Agriculture, Defense, Education, Homeland Security, Housing and Urban Development, and Transportation, as well as the Environmental Protection Agency and for International Assistance Programs. These amendments would not change the base discretionary budget authority requested in your FY 2024 Budget. These amendments are necessary to reflect correctly policies assumed in your FY 2024 Budget.

In addition, provided for your consideration is an amendment providing increased amounts for the National Science Foundation (NSF) STEM Education account. This increase is fully offset from amounts provided from within NSF and the Department of Agriculture. Also included for your consideration are amendments shifting amounts provided from within the Department of Defense for higher priority programs.

This transmittal also includes seven FY 2024 Budget amendments for the Legislative Branch. As a matter of comity and tradition, these appropriations requests for the Legislative Branch are transmitted without change. These amendments would decrease by \$17 million the overall discretionary budget authority in your FY 2024 Budget.

This transmittal also includes a technical correction to the calculation of the FY 2024 disaster relief allocation which will increase that non-base allocation by \$150 million.

Recommendation

I reviewed these amendments and am satisfied that they are necessary at this time. Therefore, I join the heads of the affected departments and agencies in recommending you transmit the proposals to the Congress.

The FY 2021 National Defense Authorization Act shifted the Coast Guard's retiree benefits plan into the Department of Defense's Military Retirement Fund, effective at the beginning of FY 2023. The Coast Guard's participation in the Military Retirement Fund is similar to the Service's current participation in the Department of Defense's Medicare-Eligible Retiree Healthcare Fund. This change in funding requirements was inadvertently not reflected in the Budget totals.

This amendment would provide \$20.4 billion for the Disaster Relief Fund, within the Department of Homeland Security. This amendment includes the corrected estimate of the funding ceiling for Major Disasters for 2024 that is described in the Budget Process chapter of the *Analytical Perspectives* volume of the Budget, as well as \$145 million for the Disaster Base. OMB has determined that the portion of the disaster formula that applies five percent of funds designated as emergency requirements since 2012 that are for major disaster activities under the Robert T. Stafford Disaster Relief and Emergency Assistance Act should have included an additional appropriation of \$3 billion that was provided in division N of the Public Law 117-328. This adjustment results in a funding ceiling for 2024 that is \$150 million higher than the estimate that was included in the Budget and this amendment aligns the 2024 Budget request for disaster relief appropriations with that updated ceiling.

The FY 2024 net budget authority totals would increase by \$150 million due to this amendment, but this correction does not affect total base discretionary budget authority in the FY 2024 budget.
